

**“AT&T ANNIHILATOR CUP WEEKLY FAN SWEEPSTAKES”  
OFFICIAL RULES**

These “**Official Rules**” of the “AT&T Annihilator Cup Weekly Fan Sweepstakes” (“**Promotion**”) shall serve to govern a set of five (5) individual weekly random draw sweepstakes (each a “**Sweepstakes**”) with each Sweepstakes having its own entry period, random drawing and prizing as detailed herein. **AN INTERNET CONNECTION AND TWITCH™ MEMBERSHIP IS REQUIRED TO PARTICIPATE IN THE PROMOTION. TWITCH MEMBERSHIP IS FREE AND AVAILABLE AT TWITCH.TV, SUBJECT TO ALL TWITCH TERMS OF USE AT <https://www.twitch.tv/p/legal/terms-of-service/>.**

This Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitch™. Any questions that you have about the Promotion should be directed to Sponsor (defined below) and not to Twitch.

**ELIGIBILITY:** Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia (collectively the “**Eligibility Area**”), who as of the date of their entry into a Sweepstakes are eighteen (18) years of age or older and a Twitch user with a valid Twitch membership account. Void in Puerto Rico, all other U.S. territories and possessions and overseas military installations and where prohibited. Employees and their immediate family members (spouses, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren) of Sponsor, Wasserman Media Group, LLC (“**Wasserman**” or “**Administrator**”), West Coast Marketing, a division of The Susquehanna Hat Company (“**West Coast Marketing**”) and each of their respective officers, directors, affiliates, subsidiaries, parent companies, and advertising and promotion agencies (collectively, the “**Promotion Entities**”) and those living in the household of same (whether legally related or not) are not eligible to enter or win. A prize won by an individual at least eighteen (18) years of age but considered a minor (“**Minor**”) in his/her legal jurisdiction of residency will be awarded in the name of said Minor’s parent or legal guardian.

The Promotion is sponsored by AT&T Services, Inc., 208 S. Akard St., Dallas, TX 75202 (the “**Sponsor**”) and by entering, participants agree to be bound by the Official Rules which can be found at [attannihilatorcup.com/officialrules](http://attannihilatorcup.com/officialrules) (the “**Tournament Rules Site**”). As stated herein, the Promotion consists of five (5) individual Sweepstakes random drawings. Members of the public eighteen (18) years of age or older (the “**Fans**”) will be invited to visit [twitch.tv/att.com](http://twitch.tv/att.com) (the “**Tournament Hosting Site**”) and enter a pre-determined hashtag command on the nightbot chat of the Tournament Hosting Site in order to determine the two (2) weekly winners of pre-determined weekly prizes.

**PROMOTION PERIOD AND INDIVIDUAL SWEEPSTAKES ENTRY PERIODS:**

Promotion starts on/about 4:00 pm Eastern Time (“ET”) on 4/2/21 and ends on/about 7:00 pm ET on 4/30/21 (“**Promotion Period**”) for entry online as detailed below.

Specific Entry Periods (each a “**Sweepstakes Entry Period**”) for each Sweepstakes are as follows:

- Sweepstakes #5 - Friday, April 30<sup>th</sup>, 2021 4:00pm ET – 7:00pm ET

**IMPORTANT NOTE: ELIGIBLE ENTRIES THAT ARE NOT SELECTED AS A PRIZE WINNER IN A SWEEPSTAKES RANDOM DRAWING DO NOT REMAIN ELIGIBLE FOR SUBSEQUENT SWEEPSTAKES RANDOM DRAWING(S) IF ANY.**

PARTICIPATION IN THE PROMOTION BY ENTRANTS (DEFINED BELOW) IS SUBJECT AT ALL TIMES TO COMPLIANCE WITH THESE OFFICIAL RULES AND WITH ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS (COLLECTIVELY, THE “**APPLICABLE LAWS**”).

**HOW TO ENTER THE PROMOTION:**

**How To Enter A Specific Sweepstakes:** To enter a Sweepstakes, visit the stream at the Tournament Hosting Site during a specific Sweepstakes Entry Period and once the “Tournament Host Site” prompts fans to enter the “Promotion”, enter #ATT Sweepstakes into the chat and you will receive one (1) entry (“**Entry**”) in that specific Sweepstakes only. **ONLY ONE (1) ENTRY PER PERSON MAY BE SUBMITTED PER SPECIFIC WEEKLY SWEEPSTAKES ENTRY PERIOD.**

Entry may be referred to herein collectively as “**Entries**” and each individual submitting such Entry referred to herein as an “**Entrant**”.

**TERMS OF SUBMISSION:** For purposes of this Promotion, an Entry in a Sweepstakes is “received” online when the Sponsor’s server records the Entry information. Proof of sending (such as an automated computer receipt confirming Entry or “thanks for entering” message) does not constitute proof of actual receipt of an Entry for purposes of this Promotion. Illegible and/or incomplete Entries and Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified.

The Sponsor’s database clock will be the official timekeeper for this Promotion. All federal, state, and local rules and regulations apply.

You understand that any personally identifiable information you provide to Sponsor shall be used only in a manner consistent with these Official Rules, and with Sponsor’s Online Privacy Policy, which can be found at <https://about.att.com/csr/home/privacy.html>.

**SWEEPSTAKES WINNER SELECTION, NOTIFICATION & PRIZES:** Two (2) potential prize winners (one (1) per random drawing) will be selected in two (2) different random drawings from among all eligible Sweepstakes Entries received for that specific Sweepstakes. Random drawings will take place at two (2) separate times during that Sweepstakes Twitch livestream, estimated timings at/about 5:00pm ET and 6:00pm ET each week on/about the following dates: Sweepstakes #1 – 4/2/21 Sweepstakes #2 - 4/9/21, Sweepstakes #3 - 4/16/21, Sweepstakes #4 - 4/23/21, Sweepstakes #5 - 4/30/21 by Wasserman or its designee.

Decisions of Sponsor, Wasserman and West Coast Marketing are and shall be final and binding in all matters relating to Promotion. Potential Sweepstakes Winners (each a “**Potential Winner**” and collectively, “**Potential Winners**”) will be notified on-stream on Twitch and will be required to

respond to such notification within ten (10) minutes of issuance. Once a Potential Winner has responded and confirmed on nightbot, a representative from Wasserman will contact the Potential Winner via direct message on Twitch. The Potential Winner will be required to provide his/her first and last name, Twitch user name, email address, daytime telephone number, street address and state of residence, age, and date of birth. West Coast Marketing will then provide the winner with required paperwork via email. The Potential Winner will then have forty-eight (48) hours to respond, verifying eligibility and providing a complete mailing address within the Eligibility Area. Failure to respond to the attempted notification detailed above or to comply with any other provision herein, may result in the Potential Winner being disqualified and an alternate may (at Sponsor's sole discretion) be selected in a subsequent random drawing from among eligible Sweepstakes Entries. A potential Sweepstakes winner will need to complete all subsequent paper work. Paper work must be scanned and email copies will need to be provided. Once a potential Sweepstakes winner has complied with all of the conditions herein, he/she will be declared an official "**Sweepstakes Winner**" for the specific applicable Sweepstakes. All winner information will be deleted one (1) year after the Promotion and will not be used for marketing purposes, see full AT&T Privacy Policy here [https://about.att.com/csr/home/privacy/full\\_privacy\\_policy.html](https://about.att.com/csr/home/privacy/full_privacy_policy.html).

Sweepstakes Prizes (two (2) prizes will be available to be awarded in each Sweepstakes). Each Sweepstakes prize consists of the following:

- One (1) Gaming backpack
- One (1) Mechanical keyboard
- One (1) Gaming mouse
- One (1) Gaming mouse pad
- One (1) Gaming headset
- One (1) Portable powerbank

Specific manufacturers, models, styles, specifications and all details of prizes to be awarded are at the sole discretion of Sponsor and/or its designee. The approximate retail value ("**ARV**") of each Sweepstakes prize is \$1,000. **The total ARV of all prizes to be available to be awarded in each Sweepstakes is \$2,000.**

Odds of winning a prize in a specific Sweepstakes are determined by the total number of eligible Sweepstakes Entries received for that specific Sweepstakes. The total ARV of all prizes available to be won during the Promotion is \$10,000.

There is a limit of one (1) Sweepstakes prize per person, email address or household address during the Promotion.

Sweepstakes prizes, may be referred to hereafter individually as a "**Prize**" and collectively as "**Prizes**" and Sweepstakes Winners referred to individually as a "**Prize Winner**" and collectively as "**Prize Winners**".

Prizes are not transferable, assignable, or redeemable for cash. Prizes may not be sold, bartered or exchanged by Prize Winners except as may be allowed by Sponsor in its sole discretion. If a Prize is returned as undeliverable or is unable to be awarded for any reason, the applicable Prize may, at Sponsor's sole discretion, be awarded to an alternate via the applicable winner determination process for the Sweepstakes as detailed herein.

**RELEASES:** The Promotion Entities, Twitch and any and all Internet server(s) and Internet access provider(s), and each of their respective affiliates, subsidiaries, parent corporations and advertising and promotional agencies, and all of their officers, directors, shareholders, employees and agents (collectively, "**Releasees**") are not responsible for any incorrect or inaccurate Entry information; human errors; technical malfunctions; failures, omissions, interruptions, deletions or defects of any telephone network, computer online systems, computer equipment, servers, providers, or software, including, without limitation, any injury or damage to participant's or any other person's computer relating to or resulting from participation in the Promotion; inability to access Tournament Hosting Site, Twitch livestream; theft, tampering, destruction, or unauthorized access to, or alteration of, Entries; data that is processed late or incorrectly or is incomplete or lost due to telephone, computer or electronic malfunction or traffic congestion on telephone lines or the Internet or any web site (including the Tournament Hosting Site and Twitch) or for any other reason whatsoever; typographical, printing or other errors; or any combination thereof.

Proof of submitting information via Tournament Hosting Site or Twitch (as detailed above) is not considered proof of delivery or receipt. Illegible, incomplete and, mechanically reproduced Entries and Entries in excess of the stated limit will be disqualified. All Entries become the property of Sponsor and will not be acknowledged or returned. False, fraudulent or deceptive Entries or acts shall render Entrants ineligible. Entrants release and waive any claims they may have against Releasees for any and all injuries, claims, damages, losses, costs, or expenses of any kind (including, without limitation, attorneys' fees) resulting from acceptance, use, or misuse of a Prize or element thereof, or from participation in this Promotion. By participating in the Promotion, Entrants affirm that they have read and accepted these Official Rules.

**GOVERNING LAW/LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants and Releasees in connection with the Promotion will be governed by and construed in accordance with the internal laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. By entering the Promotion, Entrants hereby submit to the jurisdiction and venue of the federal and state courts of Dallas County, Texas, United States and waive the right to have disputes arising out of the subject matter hereof adjudicated in any other forum.

BY ENTERING AND PARTICIPATING IN THE PROMOTION, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROMOTION, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (2) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED FIFTY DOLLARS (\$50.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (3) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND

EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES NOT TO EXCEED FIFTY DOLLARS (\$50.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (4) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

**FORCE MAJEURE:** Releasees shall not be liable to a Prize Winner or any other person for failure to supply a Prize or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, pandemic, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, network or computer problems, internet problems, hacking, computer viruses, unauthorized computer access, tampering, or any other cause beyond Sponsor's sole control.

**GENERAL:** If for any reason this Promotion or any part is not capable of running as planned, or if this Promotion or any web site (including but not limited to the Tournament Hosting Site associated therewith (or any portion(s) thereof) becomes corrupted or does not allow the proper playing of the Promotion and processing of Entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants, fraud, technical failures, or any other causes, in the Sponsor's sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Promotion, the Sponsor reserves the right, at its sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify, or suspend this Promotion or any portion thereof.

In the event Promotion or part thereof is cancelled, the Sponsor will conduct a random drawing to award the applicable Sweepstakes Prize(s) from among all applicable eligible, non-suspect Entries received for the specific Sweepstakes prior to the time of the action or event warranting such cancellation. If any such cancellation, termination, modification, or suspension occurs, notification will be posted at the Tournament Hosting Site. The Releasees are not responsible for the actions of Entrants in connection with the Promotion or part thereof, including Entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Promotion or any part thereof. Persons found tampering with or abusing any aspect of this Promotion or part thereof, or who Sponsor believes to be causing malfunction, error, disruption or damage may be disqualified. Additionally, any attempt to cheat the Promotion or part thereof, as determined at the sole and absolute discretion of Sponsor, may result in immediate disqualification of the Entrant, as well as other possible consequences, including disqualification from any and all existing and future sweepstakes, promotions or contests. If a dispute arises about who submitted an Entry, the Entry will be deemed submitted by the authorized account holder of the Twitch account used for the Entry. The natural person who is the registered user of the Twitch account is deemed the authorized account holder of the Twitch membership account used for Entry. A potential Prize Winner may be requested to provide the Sponsor with proof that he/she is the authorized account holder of the Twitch membership account associated with the winning Entry and that all eligibility requirements are met.

In the event a dispute regarding the identity of the individual who actually submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible. The Releasees are not responsible for electronic communications that are undeliverable for any reason including but not limited to, as a result of any form of active or passive filtering of any kind, suspension or technical issues with a Twitch account, insufficient space in Entrant's email account or voicemail system, or to receive email or telephone messages. Also, the Releasees are not responsible, and may disqualify an Entrant, if his or her Twitch account, email address or telephone number does not work or if it is changed without Entrant giving prior written notice to Sponsor.
